***Pre-anesthetic blood/health screening**

We provide a pre-anesthesia blood profile to maximize patient safety and alert the doctor to the presence of dehydration, anemia, diabetes and/or kidney or liver disease which could complicate the procedure. These conditions may not be detected without a pre-anesthetic profile. These tests are similar to those your own physician would run if you were to undergo anesthesia. I understand that complications could occur while under anesthesia. The doctors will minimize these risks by giving anesthetic drugs tailored to your pet's health status and by monitoring them closely while they are under anesthesia.
